
NOTICE OF MEETING

1. Call to Order.

3. Consider and approve the Sheriff's Office to purchase a vehicle less than \$50,000 from Peltier Chevrolet.
4. Consider and approve the Sheriff's Office to purchase a vehicle less than \$50,000 from Bacon Chevrolet using SB 22 funds.

 - 14.8 Authorizing the payment of the bills, payroll and transfer of funds.


15. Consider approve resolution to amend the Cherokee County Hazard Mitigation Action Plan for City of Rusk.




