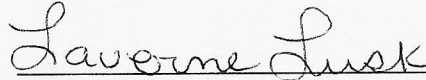
1. Call to Order.

 - 18.3 Receive order for the setting of the annual salary of the official court reporter of the 369th Judicial District of Texas for Fiscal Year 2027.

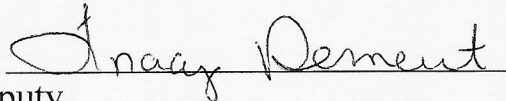
