



- 10.8 Authorizing the payment of the bills, payroll and transfer of funds.

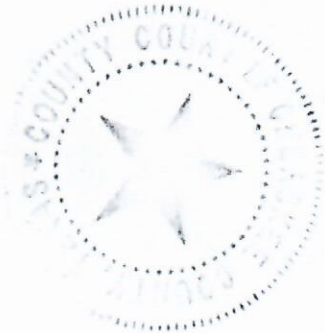

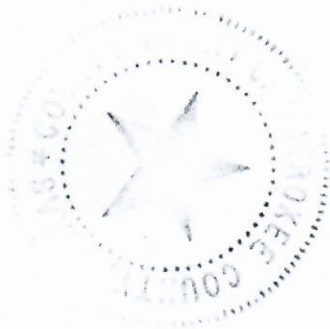
