
NOTICE OF MEETING


NOTICE is hereby given that the Cherokee County Commissioners' Court will meet in Regular Session at 10:00 a.m. on Monday, June 22, 2015 at its regular meeting place in the County Courtroom in the County Courthouse in the City of Rusk, Texas, for the purpose of:

1. Call to Order.
2. Invocation.
3. Consider laying utility lines in each precinct.
4. Consider approval to purchase a vehicle for the Sheriff Department.
5. Consider approval to sell two (2) surplus vehicles from Sheriff Department to the District Attorney's Office.
6. Consider authorization of Tax Resale Resolution.
7. Consider approval for Precinct No. 1 to assist Bengé Cemetery and removal of storm debris.
8. Consider approval and acceptance of Annual Road Report from one or more precincts.
9. Consider approval of job description of Administrative Assistant for Road & Bridge and request authorization to change existing employees currently working under the job description of Laborer, who are performing clerical work, to be moved to the new assigned step/grade and position.
10. Consider adopting an optional county fee for child safety.
11. Consider approval of Office Space Lease Agreement between Cherokee County and Jeremy Bogan.
12. Consider appointment of Elmer Beckworth to the ACCESS board.
13. Consider approval to contract with Women's Health and Family Planning Association of Texas to receive \$25,000 per year for up to four years to educate women in Cherokee County about Intimate Partner Violence.

14. Consider approval to contract with Texas Department of State Health Services and the Texas Health and Human Services Commission to obtain and provide epidemiological services for the county for a two year initial project.
15. Consider acceptance by Cherokee County Public Health, Health Advisory Board to restructure the Advisory Board.
16. Consider acceptance of dedication of Dream Lane, and add the accepted dedicated road easement into the county road system, and assigned the available road number of 3403A.
17. Consider acceptance of dedication of Patterson Lane, and add the accepted dedicated road easement into the county road system, and assigned the available road number of 3403.

 - 18.3 Authorizing the payment of the bills, payroll and transfer of funds.


