

NOTICE OF MEETING



12. Consider acceptance of concrete material from Joe Parsley of Cherokee County Precinct 4.



 - 14.7 Authorizing the payment of the bills, payroll and transfer of funds.

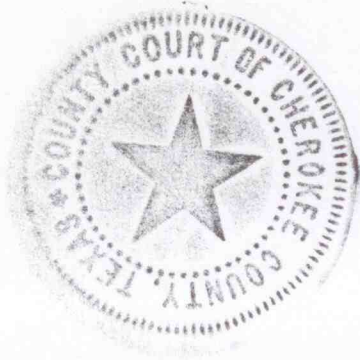
