

10. Consider approval of agreement to contribute funds between Cherokee County and Texas Department of Transportation on FM2493 and adopt Resolution.



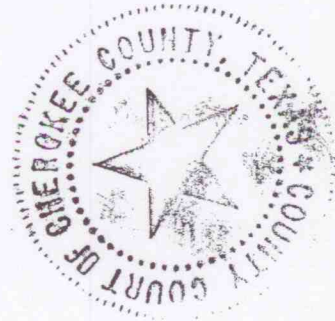
